She advised the International Finance Corporation on disruptive technologies and is lead author of the report Blockchain: Opportunities for Private Enterprises in Emerging Markets, She is a member of the EU Blockchain Observatory and serves on a number of boards, (Hellenic Corporation of Assets and Participations, Sechè Environnement, European Network of Women in Leadership). In the past, she was the CEO of the American Chamber of Commerce in France, Executive Director for the Diversity Center at INSEAD, held senior posts in the Pechiney Group in corporate strategy and served with the World Bank Group in Latin America. Ms Niforos earned an MBA from INSEAD, a Masters from the University of Pennsylvania and from SAIS-Johns Hopkins University. She graduated Phi Beta Kappa from Cornell University.

Priva Guliani is a computer science engineer by background and did a leadership course from Massachusetts Institute of Technology (MIT) and a blockchain strategy course from Oxford University. He was Senior Environmental Law Advisor to the World Bank/Russian Federation Environmental Management Project and was Regional Environmental Specialist for the Baltic Countries at the World Bank. He has been a member of the California State Bar since 1991, completed his J.D. at the University of Southern California, his B.A. in Political Science Cum Laude at UCLA, the High Potentials Leadership Program at Harvard Business School, and Computer Science for Lawyers at Harvard Law School. A recent publication of his is "The Need for an Innovation Principle in Regulatory Impact Assessment: The Case of Finance and Innovation in Europe" in Policy & Internet. An upcoming publication is "The Law and Political Economy of Decentralised Digital Ecosystems".
