### BRIDGE at a glance

BRIDGE increases digital safety and security in adult education to protect the rights and privacy of learners and provide them with safe learning offerings in order to enable those who are apprehensive of digital tools to engage in educational activities supported by digital means. It builds the digital competences of adult education institutions, educators, and learners.

### The BRIDGE objectives are:

- Increasing awareness and capacity of AEIs staff about issues of digital safety and their implications for inclusiveness and take-up of adult education to make GDPR an integral part of their ethos.
- Equipping educators with the competencies to impart digital skills while emphasizing the importance of digital safety of learners and also offering these as learning content to both adult learners and AEIs.
- Educate vulnerable adult groups, especially immigrant women, about their digital rights, safety practices, and how to protect their digital footprint to increase their confidence to engage in educational activities supported by digital tools.

## What will be the **results of BRIDGE**?

- **BRIDGE Guidebook for AElS** with assessment tool, checklists, templates, protocols, best practices, and action plans for GDPR compliance, digital safety and privacy, and digital inclusivity.
- **BRIDGE gamified MOOC** on digital safety and privacy with specific modules for each of the three target groups (AElS, educators & learners) taking their different roles and tasks into consideration, in addition to general modules on media and ICT literacy for all.
- **BRIDGE Mentorship Program** provides educators with tailored training activities to organize sessions on digital safety and privacy for other educators, as well as learners and other adult education staff.





## What have we done so far?

### Kick-off meeting in Schwerin (Germany)

On October 30, 2024 we met in Schwerin, Germany for an inaugural and inspiring project meeting, where we worked intensively with our partners to start the BRIDGE project. It was a transformative experience that bodes well for our joint project journey. BRIDGE opens the door to safer and more empowering digital opportunities for migrant women in Europe.



### Work package 2 - GUIDEBOOK for Organisational Change

In Work Package 2, each partner conducted national research and compiled reports that laid the foundation for the BRIDGE Guidebook on Organisational Change. The content and design were created and finalised and the Guidebook is now available in English, German, Polish, Greek, and Czech. The national reports brought forward some key findings, including low GDPR awareness, gaps in digital safety training, and a clear need for more inclusive and hands-on approaches for migrant women.
